## Village of Howard City Council Meeting Minutes October 21, 2019

President Heckman called the meeting to order at 7:00 p.m. Present: Smith, Williams, MacTavish, Hagstrom, VanWagner, Bassett, and Heckman. Absent: None.

Mr. Falcon informed Council that he was approached by the guitar shop downtown requesting a reserved parking spot. Council denied this request.

Council is allowing Mr. Falcon to work with Fleis and VandenBrink regarding the Village's mandatory water reliability study.

Mr. Falcon updated Council on Shane Smith's condition and expressed our thoughts and prayers are with him and his family.

President Heckman wanted Council to know that the road issue on Ensley has been milled up and taken care of. President Heckman also stated that he and Mr. Falcon had toured the Larry's Tire building and are extremely impressed with how organized and neat the facility has become.
